

The candidate must have studied under a recognized university in the following disciplines: M.C.A. / M.Sc. Computer Science / M.C.S. / M.B.A. with Systems specialization / B.E. (Computer / IT) with a Master's degree in M.Tech / M.E. / M.B.A. Certification required: CISA / CISM / DISA — possessing one of these certifications is compulsory.

Post Qualification Experience:

A minimum experience of 5 years out of which at least 2 years with Software Company (with CMMI level 4 and above) / a major organization as a Security Information Officer in a <u>centralized transaction processing environment</u>. Experience in Banking is desirable. Candidate will be responsible for:

- Security office mission and mandate development
- Security office governance
- Security policy development and management
- Security training and awareness development
- Supervision and management of ethical hackers
- Framing of Cyber security policy framework and management Coordination with Management, Head of IT Department, and Regulatory Agencies for compliance of security for the entire IT set up viz., at Data Centre, Head Office, Branches, Disaster Recovery site (DR-site), and delivery channels etc.

The candidate having knowledge of Kannada is desirable.

Desirable qualifications include professional certifications such as CISA, CISM, or CCNA. Possession of such certifications is preferred.

Post Qualification Experience:

Out of the total experience, the candidate must have at least 3 years of experience at a lead position as Assistant Manager (IT) or equivalent post. The candidate must possess experience in large-scale IT architecture implementation. Be a Technology thought leader with Software project management experience. Have exposure in handling IT Development initiatives or projects, related budgets, project management, quality of outcomes, managing outsourced IT Development, testing all solutions (developed in-house or outsourced), and handling Turnkey IT projects. Have a background in Database Management, including administration and maintenance of Database/monitoring tools/facility management. Have sound knowledge in Networks/ Systems/ applications/ technology. Have competence in handling all quality, risk, and compliance management initiatives within IT verticals such as performance or conformance metrics reports, dashboard, internal user feedback and analysis, and monitoring IT projects.

Desirable: The candidate should have managed the IT department of a bank or a major organization, with hands-on experience in banking systems, operations, processes, and technologies. They should also possess the capability to implement and manage banking-related technical solutions and coordinate effectively with internal departments.

Age Limit:

On the last date prescribed for submitting the applications, candidates must have attained the minimum age and must not exceed the maximum age limit as specified.

Selection Procedure:

Deputy General Manager (Chief Information Security Officer – CISO) and Branch Manager (Information Technology Manager –IT) examination will be conducted for 200 marks on the subjects of Banking and Development in Cooperative Banking, Banking Technology and Emerging Trends in Banking technology, Cyber security & Artificial Intelligence.

Candidates will be called for interview in the ratio of 1:5 based on the percentage of marks obtained in the written test. (The Recruitment committee is having the power to increase or decrease the above ratio.)

Candidates appearing for the written test and interview will have to attend at their own expense. The venue, date and time of the written test will be intimated separately.

Eligibility Criteria:

- 1. Must be a citizen of India
- A male candidate having more than one living wife and a female candidate who is married to a person who has another wife without prior permission from the Government shall not be eligible for appointment.
- 3. The candidate should be mentally and physically healthy and free from any physical defect to interfere with the efficient performance of the duties of his appointment.
